

COMPREHENSIVE PROJECT PROFILE

I. Project Description

- a. Project Title : Construction of Day Care Center
- b. Project Type : Capital Forming Project
- c. Project Components : Acquiring of lot, preparation of project site, purchase of construction materials, construction of Day Care Center.
- d. Project Location :
It is located in Barangay Jambawan West part of Lila, which is 7 kilometers away from the town.

II. Project Status

1. Proposed Project:

Construction of Day Care Center is a proposed project to be implemented in barangay Jambawan, Lila. Presently, this barangay has an existing Day Care Center in which the area is like a pigpen, not conducive for learning. The children are not comfortable and safety during their Day Care Session and barangay Jambawan is a depressed barangay with a vast number of pre-school children enrollees. Due to budgetary constraints, as of this time, proposed project has not come to reality.

III. Project Justification

1. Project Background

Barangay Jambawan is one of the depressed barangay in the Municipality of Lila. It is more or less 7 kilometers west away from the town proper. It has a total population of 493 or 89 households. With the vast increasing number of pre-school children enrolled in the

temporary Day Care Center, it could not be enough and not conducive anymore for its desire purpose. They need substitute parental care in a proper place so that children would become productive as far as their psycho-social being is concerned.

Day Care parents committee made a constant request of establishing a Day Care Center. The barangay council could only do but to cater to their temporary center knowing to its budgetary constraints. Based on the 2004 Poverty Database Monitoring System data, barangay Jambawan had 3.51% school dropouts, 75.28 below income threshold (rank first among the 18 barangays) and 9.89% unemployed person. As of this time, the pre-school children of the barangay need a new Day Care Center with fervent hope that it would come to reality.

2. Project Objectives:

1. To provide supplemental parental care to 0 - 5 yrs. old child who may be neglected, potentially neglected, abused, exploited or abandoned, during part of the day when the parents cannot attend to their needs.

2. To help the pre-school child become physically fit and healthy through proper care and nutrition, monitored growth and development and early detection of disease. Also included are various play activities and games to develop physical fitness.

3. To help preschool child develop self-confidence, self-expression and self-discipline through activities such as dressing, eating, sleeping and how to use the toilet.

4. To help the pre-school child develop his mental, intellectual, verbal and language skills through arts and crafts, listening to music and all other forms of creative activities.

5. To provide comfort and safety for the preschool child during day care sessions, as well as protection from all forms of neglect, abuse, cruelty and exploitation.

3. Sectoral Objectives:

The parents will be benefited since Day Care children will be left in Day Care Center and that they could earned income for the whole family.

4. Regional and National Objectives:

The Regional and national level will keep on lobbying to the higher authority for giving financial support and attainment of the project and making legal basis beneficial for the children.

IV. Project Financing:

1. Funds Needed : Php 500,000.00
2. Funding Source : Provincial Government and National Government.
- 3 Counterpart Funding : LGU and Brgy. Level

The Municipal Government will provide technical assistance and the barangay will be the one to provide the lot needed for the center. The National Government will provide for the construction materials and labor costs.

V. Project Benefits:

a. Beneficiaries:

Direct beneficiaries of the project will be the preschool children age's 3-5 years old including the parents since the children will be left in the center, thus substitute mothering would be provided.

b. Social Benefits:

It will give positive effects on the lives of the children and better access to employment opportunities to parents.

VI. Project Implementation:

1. Responsible Agencies

The implementation of the proposed project will be administered jointly by the barangay development council and Day Care parents committee under the supervision of the technical staff of the municipal government unit of Lila including the staff from Provincial Government of Bohol who will supervise this project.

The Municipal Engineer and Municipal Planning and Development Coordinator shall periodically monitor and evaluate the project and will see to it that the plans and specifications will be followed during the project implementation.
